A. Update on Santa Margarita Water District Canada Gobernadora Multipurpose Basin.

Don Bunts provided an update. He explained The Cañada Gobernadora Multipurpose Basin project is located within an unincorporated portion of southeastern Orange County, just south of the community of Coto de Caza.

The proposed basin will capture and naturally treat urban runoff and storm flows, and use that water to help meet irrigation demands in the nearby community.

The Gobernadora Basin project will consist of a storm retention basin and a natural treatment system, a system to capture and divert flows to the wetlands, a pump station, and a pipeline to deliver flows to the Portola Reservoir, a recycled water reservoir located in Coto de Caza.

There are two phases: Phase 1 is expected to be completed by the end of 2013; and Phase II to be completed July 2014.

The project benefits are:

- Reduce downstream erosion and sedimentation of Gobernadora Creek, a major tributary of San Juan Creek.
- Enhance local water supplies by capturing urban flows for outdoor irrigation use, decreasing the need for imported potable water.
- Improve the water quality in the Gobernadora Creek, which flows downstream to the Gobernadora Ecological Restoration Area (GERA).

Mr. Ferons noted this project is outside the SJBA Groundwater Management Plan.

Regarding the updated SJBA Ground Water Management Plan Mr. Ferons reported no comments have been received to date. In addition to the regularly scheduled Board meeting on September 10, 2013, a public hearing will be conducted during which public input will be received. He encouraged reviewers to provide written comments prior to the September 10 meeting.

Depending upon the outcome of Public Hearing at the September 10, 2013 meeting, the Board has tentatively scheduled an adjourned meeting for September 16, 2013 to conclude and address any outstanding items.

Mr. Ferons noted a copy of the draft San Juan Basin Groundwater Management and Facilities Plan is available through the website.

DISCUSSION

Wildermuth Environmental has prepared a draft update of the Groundwater Management and Facilities Plan (GWMFP) for the San Juan Basin. The document has been released for review by the member agencies and is proposing to release the draft document for public review following the September Board meeting. Wildermuth Environmental will make a brief presentation on the draft document at the September Board meeting. It is anticipated that all member agency comments will be received by the September 10, 2013 Board meeting.

The Authority will hold a public hearing with notice pursuant to Section 6066 of the Government Code to consider a resolution of intention to adopt a groundwater management plan at the October meeting, at which time a final draft that addresses those comments submitted shall be released. The Authority will schedule a subsequent hearing at the November Board meeting to consider adoption of the plan and shall also consider any protests to the adoption of the Plan.

SUBJECT: Update on The Metropolitan Water District of Southern California Foundational

Action Funding Program

DISCUSSION

The Municipal Water District of Orange County submitted an application for funding under the MWD Foundational Action Funding Program on behalf of the Authority. The project, along with the Doheny Desalination Project, has been recommended for funding by the MWD review team and its Board of Directors is considering authorization at its September 10, 2013 meeting. The recommendation relating to the Authority's project that is being forwarded to the MWD Board of Directors is for a \$200,000 grant.

If approved, the Authority Technical Advisory Committee (TAC) will convene along with MWDOC and the Doheny Desalination TAC to develop the final scope of work for each project to ensure overlapping issues are adequately addressed to maximize the value of the grants and advancement of the respective projects.
